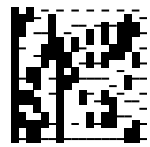

Peb cov ntaub ntawv qhia hais tias Tus Neeg Txiaiv Txim nrog rau Division of Employment Security (DES) tau txiaiv txim siab tias koj tau txais them nyiaj tshaj los ntawm cov nyiaj pab kas phais poob haujlwm hauv cov nyiaj qhia saum toj no vim muaj kev dag ntxias lossis tsis raug txiaiv tawm ntawm koj tog thiab / lossis koj qhov kev tsis qhia cov nyiaj khwv tau los uas yuav tsum tau. Qhov Kev Txiaiv Txim tau ua rau them nyiaj tshaj thiab qhov laj thawj no tau tau poob rau hauv qab ntawm N.C.G.S. § 96-15 (b) (2). Koj tuaj yeem thov ib daim ntawv luam ntawm qhov kev Txiaiv Txim los mus txhawb nqa koj cov nuj nqis uas yog hu rau Tus Kws Tshawb Xyuas Rov Qab. Raws li hnub tim ntawm Daim Ntawv Ceeb Toom, koj tsis tau them tag rov qab cov nyiaj pab thiab/lossis raug nplua rau hauv nqe lus nug.

DES thov kom xa koj cov nuj nqi them raws li cov nqi them poob haujlwm ua haujlwm them rau Lub United States Department of the Treasury/IRS (Treasury) rau kev sau nyiaj los ntawm Treasury Offset Program (TOP). Los ntawm TOP, lub Txhab Nyiaj tso cai tau txais kev txiaiv nyiaj los ntawm koj cov nyiaj se them nyiaj khwv tau los rau Tsoomfww los mus them rov qab rau koj cov nuj nqis hauv DES. Yog tias koj cov nuj nqi raug xa mus rau TOP, koj yuav tau them tus nqi rau qhov kev sau nqi ntawm kaum xya duas (\$17.00). Yuav kom zam qhov kev txiaiv koj cov nyiaj them se rau Tsoomfww thiab tus nqi ntxiv no, koj yuav tsum ua ib yam ntawm cov hauv qab no tsis pub dhau rau caum (60) hnub tomqab ntawm daim ntawv ceebtoom no:

- Them koj cov nuj nqis kom tag. Xa koj cov nyiaj them tuaj nrog rau daim ntawv no mus rau qhov chaw nyob saum toj no, Tshaj Tawm Rau: Kev Tswj Kev Them Nqi Cov Nyiaj. Ua koj daim tshev nyiaj los yog nyiaj them xa mus rau Division of Employment Security. Koj kuj tuaj yeem them cov nqi ntawm credit card ntawm DES lub website ntawm des.nc.gov, los yog hu rau Tus Kws Tsawb Qhov Qab ntawm 919.707.1338.
- Nkag mus rau hauv daim ntawv cog them nqi thiab txuas nrog cov lus cog tseg. Yog tias koj tsis tuaj yeem them koj cov nuj nqis tag nrho, koj tuaj yeem thov kom nkag rau hauv daim ntawv cog lus them nqi. Koj yuav tsum tau hu rau Tus Recovery Specialist nyob rau hauv rau caum (60) hnub ntawm daim ntawv ceeb toom no, pom zoo rau qhov kev npaj them nqi rau DES, thiab them rau qhov yuav tsum tau them.
- Thov rov ntsuas xyuas koj cov nuj nqis. Ua raws li 26 USC. § 6402 (f) thiab 31 CFR § 285.8 (c) (3) (i), koj thov tau rov qab soj ntsuam ntawm koj cov nuj nqi los ntawm cov pov thawj tias tag nrho los yog ib feem ntawm koj cov nuj nqis tsis yog kev dag thiab / lossis nyiaj haujlwm xyoo, thiab/los yuav tsis raug txiaiv mus them. Koj cov pov thawj yuav tsum muab xa mus rau qhov chaw nyob hauv qab no, Xaj: Kev Tswj Kev Them Nqi, los yog xa los ntawm tus fej los yog email hauv qab no. DES yuav xam tag nrho cov pov thawj uas tau muab nthuav tawm thiab yuav ceeb toom rau koj (ntawm xa ntawv) ntawm peb qhov kev txiaiv txim siab seb koj cov nuj nqis yuav raug xa mus rau Treasury.
